Notification of BOD Election

**[Para 7, 12 of Election no 98 of 2025-26 dtd 22.08.2025 of Co-operative Election Authority,
Ministry of Cooperation, Govt of India]**

Notice to all the Delegates of CAD & AAI Employees Co-operative Society Calcutta Ltd.

Pursuant to the direction given by the Co-operative Election Authority, Ministry of Cooperation, Government of India vide no. Election no. 98 dated 22.08.2025; it is notified that the election of Board of Directors of CAD & AAI Employees Co-operative Society Calcutta Ltd. is to be held in the Annual General Meeting on 16.11.2025 as per schedule given below. In this respect all the members are requested to follow the guideline as stated under: **There are 12 seats in the Board of Director, out of which two seats are reserved for Women & one seat for SC/ST.**

1. The election process i.e., submission of objection & disposal of the same of provisional & final voter list, submission of nomination papers, scrutiny of nomination papers & withdrawal of nomination papers & voting by delegates will be held at the office of CAD & AAI ECCS Calcutta Ltd., New Quarters, NSCBI Airport, Kolkata 700052.
2. There will be Nomination Form for three categories. **The Delegate member filling nomination should clearly mention in the nomination form the category from which he/she desire to contest or else the nomination paper is liable to be cancelled.** Delegates desirous to file nomination in the SC/ST category should submit SC/ST certificate issued by competent authority. Nomination Form shall be supplied, on request, by the Assistant Returning Officer or any other officer authorized by her in this behalf, to any delegate member of CAD & AAI, free of cost.
3. Every Nomination Form shall be signed by two delegate members whose names are included in the list of the delegate members and one of the delegate members shall sign the Form as Proposer and the other as Secunder for the nomination.
4. Withdrawal of Nomination may be done by any candidate by notice in writing signed by him and delivered in person or by the person duly authorized by him within the date and time specified in the election programme for such withdrawal. The signature in the withdrawal request shall be tallied with the signature inscribed in the Nomination Form. The Notice for withdrawal of candidature given by the candidate shall irrevocable.
5. No Delegate is entitled to file Nomination for contesting in the B.O.D election as a Candidate if he/she has made any default in payment of any amount to be paid to the Society as on the date of filling the Nomination Form.
6. No Delegate who has been a member of the Society for less than twelve months immediately preceding the date of such Election is eligible for filling nomination paper.
7. No Delegate members of the Society shall be eligible for being a member of the Board of the Society if such member acquires disqualification as stated under Section 29, 43, 44 of the M.S.C.S. Act, 2002 & 19J, 19K & 19L of the M.S.C.S. Rules, 2002(Read with amendments).
8. The Term of office of elected members of the Board and its Office Bearers shall be five years from the date of Election and the term of Office Bearers shall be co-terminus with the term of Board.
9. Nomination Form may be presented in person by the candidate himself or by his authorised person whose name is in the delegate member list, to the Assistant Returning Officer or any other officer authorised by her on the date, time and place/venue specified for submission as per programme, published by CEA.


